



## 2010 COLORADO THUNDERBIRDS MIDGET SPRING/SUMMER TRAINING

Come train with the Colorado Thunderbirds – one of top AAA programs in the country and proud members of Tier 1 Elite AAA Hockey league. The following sessions are open to all Midget players that want to train and develop at a AAA level. The summer training sessions will consist of 25 hours of on ice skill development in a competitive, challenging, and fun environment. Small games and full-ice scrimmages will be a part of this advanced training program.

All sessions will be held at the newly renovated Big Bear Ice Arena in Denver, Colorado and will be run by our elite Midget AAA coaching staff: Angelo Ricci, Kevin Whalen, Scott Smith, John Seymour Justin Waldron, Cam Clemenson and other Thunderbird coaches and special guest instructors. Goalie coach Brian TenEyck will oversee the goalie training. You must register according to your birth year but the Thunderbird staff reserves the right to move players between sessions. Space is limited. It is recommended that players who are interested should register early. Registration cost is \$475.00. **No check equals No spot.** The camp fee is **non-refundable**.
